

WPASA O-30 Playoff 2014

Gentlemen

Congratulations to Tartan Devils FC who beat Cranberry FC and Mon Valley United who beat Indiana County FC in the O-30 playoff finals on Sunday November 2nd.

- A) This year's WPASA playoffs will be played in the Fall with first round games the weekend of October 19th . Semi Finals are scheduled for October 26th and finals for November 2nd.
- B) Finals for each division at North Strabane Park on November 2nd 2014 at 1pm and 3pm. Field fees, ref fees and ref assignment fees paid by the WPASA for the finals.
- C) Participating teams split the ref fees for the knock-out matches on 10-19-2014 and 10-26-2014; Home team pays for the field for the knock out rounds; WPASA pays for the assignment fees for the knock-out matches.
- D) WPASA pays for all trophies and Golden Boot Plaques.
- E) Regular season matches from both spring and fall will establish the seeding using all match results up to and including October-5-2014 and matches have to be reported to Michael Hill by noon Monday 10-6-2014.

- A) Single elimination. (knock-out matches)
- B) Higher ranked team based on results of both spring and fall season will determine what teams host the first and second round matches.
- C) All league games must be played no later than 11-9-2014 from both spring and fall seasons to impact promotion and relegation for the Spring of 2014.

Matches will be 45 minutes per half; if game ends in a tie there will be two 15 minute overtime periods with a golden goal prevailing. If the two overtime periods end without a score then the match will be determined by PK'S at the end of the OT periods. Home teams provide the game balls. If both teams have the same color jerseys the visiting team shall have the final say as to the jersey color of their choice. No slide tackling. All players to be eligible must be listed on a formal roster form with all of the necessary documented information on it, player passes (the photo ID) must match the information contained on the legal roster.
